It is understood that Purebred Cat Breed Rescue does not buy or pay for cats. This is a service to help place purebred and purebred mix or lookalike cats in new homes when their present owners can no longer keep them. This service is free, however a donation to help pay for expenses is always appreciated.

Please read, sign and date the following:

I, \_\_\_\_\_, hereby release, relinquish all rights, & make available for adoption, ALL THE CATS I OWN EXCEPT FOR \_\_\_\_\_, to PUREBRED CAT BREED RESCUE (PCBR). I certify that the cats remaining here are spayed/neutered and I will provide proof of same on request.

I certify that I am the owner of this particular cat, free and clear of all other interests. The information I have provided about each of these cats is true and complete. I hereby forever release, discharge and agree to hold harmless, indemnify and defend the PUREBRED CAT BREED RESCUE, INC. and their boards of directors, their members, officers, and agents from all claims, demands, actions, causes of action, or liability of any kind whatsoever arising as a result of or in connection with the adoption or other disposition of the above named cat.

I certify that no other person or entity has ownership rights to any of these cats. I confirm that in relinquishing ownership of these cats to Purebred Cat Breed Rescue, I have agreed that I will no longer be breeding cats and have no plans to resume breeding cats within 5 years. In addition, I agree that should I resume breeding cats within 5 years of this date, I will be responsible for payment of \$250 per each cat rescued today as liquidated damages.

Any breach or non-fulfillment of conditions will be considered a substantial breach of this agreement by owner signing below. If there is such a breach, PCBR may, at its option, terminate this agreement immediately. In addition, it is agreed that PCBR will be substantially damaged by the failure of the owner to cease breeding for a minimum of 3 years, and that, considering that precise damages are difficult to calculate, the owner agrees to pay to PCBR the sum of \$250.00 per cat rescued from their cattery on this date should the owner fail to fulfill the minimum three year contract. In addition to liquidated damages, it is

agreed that PCBR will recover from you any other consequential damages, and reasonable attorney's fees, if this contract is breached.
